

Lloyd B. Miller has practiced law since 1979 in Washington D.C. and Alaska with the law firm Sonosky, Chambers, Sachse, Miller and Munson, LLP, specializing in federal Indian affairs. A major part of Mr. Miller's practice involves representing tribal health care and governmental service providers operating federal facilities and programs under contracts and compacts with the U.S. Department of Health & Human Services and the U.S. Department of the Interior. In related areas, Mr. Miller was deeply involved in the legislative processes leading to the 1988, 1990, 1994 and 2000 Indian Self-Determination Act Amendments, in additional amendments dealing with eligibility and tort claims issues, and in the regulatory processes which followed those amendments. His litigation activities include a 2002 class action recovery of \$29 million against the BIA over unpaid contract support costs, a 2005 Supreme Court decision in Cherokee Nation & Shoshone Paiute Tribes vs. Leavitt (resulting in the recovery of \$24 million against IHS), and a 2008 recovery of \$44 million against IHS for an Alaska Native tribal provider. Mr. Miller is counsel for the petitioner in Arctic Slope Native Assoc. vs. Sebelius and co-counsel for the respondents in Salazar vs. Ramah Navajo Chapter, both pending before the Supreme Court and involving the government's contract support cost payment obligations. He has also long represented the National Tribal Contract Support Cost Coalition, working to permanently end contract support cost underpayments that have penalized Tribes exercising their ISDA rights of self-determination. Mr. Miller received his undergraduate degree from Yale University (1975) and his law degree with honors from the University of Virginia (1978). He previously clerked for the late U.S. District Court Judge James M. Fitzgerald for the District of Alaska (1978-79).
