**MANAGER'S AMENDMENT
TO LEGISLATIVE BRANCH APPROPRIATIONS BILL**

Page 18, line 4, strike "\$10,000,000" and insert "\$17,000,000".

Page 19, line 14, strike "\$33,697,000" and insert "\$26,697,000".

Page 19, line 15, strike "\$16,164,000" and insert "\$9,164,000".

Amend the Committee Report accordingly.

In the Committee Report, at the appropriate place in the portion of the Report relating to the House of Representatives, insert the following:

1 *Garage Security Implementation Plan:* The Committee
2 commends the Sergeant at Arms of the House of Rep-
3 resentatives and the Capitol Police for their work to secure
4 the Capitol Complex. The Committee notes that a plan
5 to install magnetometers at the entrances to the House
6 office buildings leading from the garages is a significant
7 step forward in closing one of the last gaps in internal
8 building security. Having said that, it is clear that the ga-
9 rage magnetometer program as presented will not be oper-

1 ational in all of the House office buildings, making it less
2 effective than a program in which all three buildings could
3 be secured simultaneously. Nonetheless, comprehensive
4 garage security should move forward and the Committee
5 expects the Sergeant at Arms and the Capitol Police to
6 implement those security efforts after providing a plan
7 that will outline how the program will be implemented in
8 all garages. Furthermore the Committee encourages the
9 Sergeant at Arms and the Capitol Police to hold additional
10 briefings to re-introduce and re-orient offices to the details
11 of the plan required above, including providing informa-
12 tion to new Members who will join the 115th Congress.
13 *Donating Computer Equipment:* The Committee is aware
14 of several Member's desire to review the regulations that
15 outline the eligibility of, and process by which, House
16 equipment can be donated to local and State governments
17 as well as 501(c)(3) charities. The Committee believes this
18 is a worthwhile review and that the Committee on House
19 Administration is the proper committee of jurisdiction to
20 address any specific regulation changes.

In the Committee Report, at the appropriate place
in the portion of the Report relating to the Library of
Congress, insert the following:

21 *Survey:* The Committee directs the Library of Congress
22 to conduct a survey of ethnic collections of populations dis-

1 placed as a result of World War II conflict found through-
2 out the United States, and to share the results of the sur-
3 vey with the Committee.
